Dr. Baldino moved to approve the minutes as modified above and Prof. Simmons seconded the motion.

Business
Proposal:

Dean Paraska said that he agreed with the written statement given to the Academic Affairs Committee by Dr. Smolen on October 2, 1980. Dean Paraska indicated that he fully supported the attempt of SBA to achieve accreditation, however, the needs of BET students should also be met. Dean Paraska stated that with these two goals in mind he supports the SBA proposal with the understanding that CAST would develop courses for BET students. Several members of the committee did not feel that it would be the position of SBA to support

development of the courses in the College of Applied Science and Technology. It was pointed out that SBA's written statement clarifies this point, however there appeared no agreement among the committee members as to the position of SBA on this point. Discussion about the SBA proposal also brought out the following observations:

- (a) The School of Business students are urged to take all the general requirements in their first 2 years, in order that they may devote their time-effort on the business courses in their third and fourth years.
- (b) The two-year students presently enrolled in BET will be allowed to finish their 2 year degree taking School of Business courses.
New students in the Fall of 1981 would not be allowed to take School of Business courses but in fact take the new BET courses if this proposal is approved by the Senate.
- (c) If BET students take courses offered by CAST, the credit for such courses would not be automatically transferable to a SBA program. Some method of evaluation would have to be instituted by SBA for credit transfer.
- (d) Some members felt that it would not be desirable if we (YSU) allow the BET programs to become nontransferable to SBA and that the transferability should be maximized not eliminated.
- (e) Some of the members felt that the transferability should not be automatic and pointed out the lack of automatic transferability that exists between the Engineering Tech. and the School of Engineering program.

After Dean Paraska excused himself from the meeting there was further discussion and a consensus was reached on two points:

- (1) Dean Paraska and Dean Dodge be invited to the next meeting to clarify their positions.

- (2) The Committee would take up the proposal for a vote at the next meeting.
