MINUTES OF SPECIAL MEETING OF BOARD OF TRUSTEES OF YOUNGSTOWN STATE UNIVERSITY

Pursuant to notice duly given, a special meeting (the two hundred fifty-ninth) of the Board of Trustees of Youngstown State University convened at 1:30 p.m., Tuesday, May 10, 2005, in the Board Room in Tod Administration Building.

The acting chairperson called the meeting to order.
