
Dear Les,

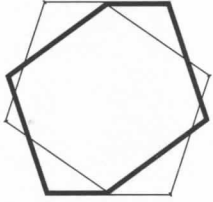
The total treasury, therefore, stands at \$15.00.

Dear Professor Domonkos:

On the basis of the AHA Newsletter announcement on ICHS topics for the XVth International Congress of the Historical Sciences in Bucharest, I would like to inquire, whether there is still room in the U.S. delegation for yet another participant.

Since my postdoctoral fellowship at the Davis Center (Princeton) in the early 1970s, I have been working on the area of "Academic Illiberalism: Students, Society and Politics in Imperial Germany." In two weeks I shall leave on another research trip to Europe to work especially on the problem of the political influence of the professors on their students. This involves the first day's topic since I intend to approach it through both the obligatory Festreden and the scholarly lectures dealing with political subjects. As you will be able to gather from my enclosed cv and the appended research proposal, I have been concerned with any number of other questions (such as stratification, socialization, educational expansion, perhaps also professionalization) which might fall under the second day's heading. Several of my articles are still in press (such as the piece on liberal education which is forthcoming in the Journal of Modern History). But I believe that you can already get a fair reading of the method and quality of my work from my earlier contribution to the Stone volumes on the sources of German student unrest.

Hence I would like to get your preliminary impression on whether there is still space and whether you might be interested in having this kind of work represented.

## B. Description of Proposed study:

### A BETRAYAL OF HUMANISM: Students, Society and Politics in Imperial Germany

A central paradox of German history is the failure of the Akademiker as political leaders despite their public prominence and social prestige. Although in the last decades of the 19th century the German university reached the zenith of its international reputation as cradle of Wissenschaft, the liberal education which it conveyed in the name of Bildung led to illiberal responses of its graduates to the successive crises of war, revolution, depression and the rise of National Socialism. The erosion of the liberalizing impulses in the neohumanist heritage and the ideological reorientation of the academics towards authoritarian patterns is highly significant since it was not the cohort of Weimar students, but their predecessors during the Empire which occupied the key decision-making positions in culture, society and polity between 1914 and 1939. Hence this study seeks to explore the dual process of social selection and political education of academic youth between 1870 and 1918. Although the protest movement of the Burschenschaften (leading up to the 1848 revolution and to unification) and the protofascist activism of Weimar radicals have received a great deal of scholarly attention, little if anything is known about the collective biography of the students who came of age in between. In order to understand the great political reversal of the educated elite, two questions need to be answered: Who were the students in social terms (cf. Max Weber's hint about the pivotal role of education in the Central European status hierarchy)? And what were their common "unspoken assumptions" (James Joll), their habits of mind, their cultural styles and their ideological proclivities?

The forces which shaped the academics' claim to be the special guardians of the national spirit were complex. After 1865 the rhetorical tradition of Humboldt was confronted with an unparalleled expansion of student numbers (2.5 times faster than the population growth) which led to the emergence of the mass university, and to an excess of educated men, provoking calls for academic protectionism. Partly as cause, partly as consequence of the enrollment boom, the social composition of the student body changed drastically towards more modern high-school graduates, women and Catholics, thereby curtailing its predominant self-recruitment and allowing first the sons of the propertied upper middle class and then also the children of the new lower middle class access to higher education. This social transformation complicated the tasks of cultural policy and formal instruction which sought to train students either for their roles as future state officials or as scholars-to-be and stressed patriotism while limiting the freedom of inquiry to strictly scientific concerns. The hidden curriculum of peer-group subculture, student organizations etc. tended either towards ritualistic corporatism of the duelling Corps or towards Rightist causes (such as the anti-semitic, imperialist Vereine deutscher Studenten). Although there was a reformist minority (organized loosely in the Finkenschaft), its influence was limited to student concerns and failed to sway the mass of unaffiliated careerists (Brotstudenten). The resulting mentality of Imperial German academics was a curious combination of 1) cultivation idealism 2) combined with educational elitism and 3) a political nationalism. Perhaps this academic illiberalism provides a clue as to why the prestigious Bildungsbürgertum which had stood



in the forefront of liberalism during the first three quarters of the 19th century, fell prey to the traditionalist (William II) and revolutionary (Hitler) ideologies of the Right.

Because of the fragmentation of German records, this kind of study must proceed on several levels at the same time. Published Prussian statistics provide the backbone of the enrollment analysis. A case study of the Bonn matriculation register (a systematic 10% sample of the entries for the 1840s and from 1865 to 1914) serves as basis for the discussion of the social transformation (supplemented by a similar analysis for Göttingen 1835-1900). The archives of the Prussian Ministry of Culture at Merseburg allow inferences about the official student policy while the professorial Festreden and published political lectures at the University of Berlin permit conclusions about the impact of the formal curriculum. The vast pamphlet and journal collections of the Institut für Hochschulkunde in Würzburg together with the files of individual corporations (Burschenschaftsarchiv Frankfurt) substantiate hypotheses about the influence of student subculture. Finally the student organizational records at the University of Marburg make a sociology of student associations possible. The analysis of this and other documentary evidence (archive of the imperial chancellery and the Freistudentenschaft in the Bundesarchiv Coblenz) requires a skillful blending of qualitative and quantitative methods. Although integrating some conceptual impulses from the social sciences, the basic methodology of the study is thoroughly humanistic, since it approaches a value question in historical terms.

Such a social history of higher education is both a continuation of and a departure from my previous work. My earlier research on Germany during the First World War and in the 1930s convinced me that literal examination of diplomatic or domestic documents has only limited explanatory power and that one needs to look beneath the surface of politics into the social and ideological forces shaping men and events. My articles on the sources of German student dissent in the prerevolutionary era (1815-1848) and my investigation of a sample of 7500 students in the first three quarters of the 19th century allowed me to develop the necessary practical and conceptual tools. A Humboldt-Stiftung Dozenten Stipendium permitted the gathering of the source materials and some preliminary exploration of the problem in essays, papers at conferences, workshops and colloquia on both sides of the Atlantic. In order to explore some preliminary conclusions I treated the issue of "Liberal Education as Illiberal Socialization" in an essay which will appear shortly in the Journal of Modern History and submitted a companion piece on "The Social Transformation of the German University" to the Journal of Social History. Since it is becoming more apparent that these problems are not unique to Germany, I am currently negotiating with QUANTUM about a collective volume on "Education and Social Change in Modern Europe" which would approach the questions of enrollment, stratification, and professionalization in a comparative and interdisciplinary perspective.

The purpose of this application is, therefore, to gain free time for full-time reflection and writing. Teaching, administrative duties and organizational commitments do not allow the necessary creative leisure for a major monograph. The internal logic of a study of this scope requires: 1) funding for the gathering of source material (provided by the Humboldt Foundation in 1975-76) 2) a period of subsequent evaluation of the documentation, which will be completed by the summer of 1979 and 3) further outside

support for the actual writing of the manuscript while the research is still fresh and the ideas are alive. The fellowship should enable me to complete the entire first draft, expose it to criticism by other scholars and revise it in a manner suitable for publication. Because there is really no center for the comparative study of humanistic higher education (with the possible exception of the Institute for Social Policy Studies at Yale University), I am presently exploring several locations which provide appropriate library resources and a stimulating intellectual community, such as the Institute for Advanced Study in Princeton or the Center for Advanced Study at Stanford University.

The upsurge of interest in the social history of education on both sides of the Atlantic has been astounding. Aside from such conventional affairs as panels at the AHA meeting and at the German Historikertag (in which I have participated), there has been a revitalization of scholarly organizations such as the History of Education Society or the Historische Kommission der deutschen Gesellschaft für Erziehungswissenschaft, the improvement or founding of journals such as the History of Education Quarterly and the Informationen zur Erziehungs- und Bildungshistorischen Forschung. Along the same lines I have recently organized new network on "Society and Education" within the Social Science History Association. Several fascinating studies (by Müller and Riese) have recently appeared in the Federal Republic of Germany and others here (by Ringer and McClelland) are still on their way. Although there has been considerable interest in my findings, there is to my knowledge no one in either country who is seriously working on the problem of students, society and politics in Imperial Germany. Hence another aim of my work is to make a methodological contribution to the study of the transformation of higher education from a traditional to a modern elite system which can stimulate a comparative debate.

In general, I see the significance of this proposal not only in terms of German or European history, but also in light of the issue of the social and political implications of certain forms of humanistic knowledge. The relationship between educational opportunity and democracy is by no means clear. The connection between liberal education and political liberalism is not at all simple. The case of the Imperial German university provides a particularly instructive, if largely negative example of the degeneration of institutionalized neohumanism into empty rhetoric, masking educational elitism and chauvinist nationalism, whose disastrous political consequences can hardly be exaggerated. Hence the humaneness in humanism should not be taken for granted. The role of equality and freedom in liberal education needs to be rethought by every generation.



Dear Professor Verger and Respected Colleague:

Upon my return from Europe, I found a letter dated July 4, 1978, from the Secretary General of the International Congress of Historical Sciences remarking that he had not received the name of the Rapporteur for our 1980 Bucharest meeting.


Dear Leslie,



Four address times of 20 minutes each were reserved for the participants from the United States. A final selection will be made by the representatives of the 18 nations comprising the International Commission.

L. Gabriel, President of the International Commission for the History of Universities affiliated with the International Committee of Historical Sciences, University of Notre Dame, Notre Dame, Indiana 46556.

Professor A. L. Gabriel, Director of the Ambrosiana Collection, a Project of the Samuel H. Kress Foundation, presided and chaired the Congress on History of the Universities of Enlightenment held in Warsaw and Cracow, Poland, during the week of September 1-6, 1977. Professor Gabriel gave the opening address in greeting the President of the University of Warsaw, Professor Z. Rybicki. Professor Leslie S.
