Dear Les:

How good it was to see you and Eva in Stuttgart! Wonderful as the US is, one of its drawbacks from my standpoint is its size: we are so far separated from one another that the times when we can share together are all too few and far between. I hope that the two of you had a continued good stay in Germany. Mine was all too short, for after an afternoon and evening with the (extended) family with whom I stayed as an exchange student in 1955, I came back to Stuttgart and flew home on Monday, Labor Day. Our classes began the next day, and I still had syllabuses to write!!

When you have a chance, Les, fill me in on the trip to Tübingen and the developments in the International Commission. I know nothing of the outcome and would appreciate both official and unofficial news and rumor.

This fall one of my courses is my East Central Europe in the Middle Ages. As usual, the enrollment is small, but I appreciate my university letting me teach it. As before, I am finding that I know more about Bohemia and Poland than Hungary. In fact, I have resolved to concentrate for a while on Hungary by doing some reading. Can you suggest things in the western languages, English first preference, German next, French third, on medieval Hungary that would help me. I am generally familiar with the older literature, but know little of the post-war historiography. Anything you can suggest would be appreciated.

Our semester is off to a good start. I have a large survey of medieval history (about 75 students) in addition to the course I mentioned above. And, much as I enjoyed being on sabbatical last Spring, it is nice to be back in harness again. Sue sends her love and best wishes. Hugs and kisses to Eva and the children.

Ihre Aufsätze, die mich alle außerordentlich interessieren, habe ich z. T. bereits gelesen, so besonders und zuerst alles, was die ungarischen Universitätsgründungen des 14. und 15. 
Thank you for your recent note. As you can imagine, I was certainly surprised to hear from you; however, I was more delighted than surprised.


This program is being sponsored by the Canfield Education Association.

A general introduction by the editor discusses the significance of each of the works, its relation to the others, and its subsequent fortunes, as well as Erasmus' views on education. These volumes are 352 and 400 pages in length respectively and sell at a list price of \$95.00 for the pair. As a contributor to the CWE, the Erasmus Studies series, or Contemporaries of Erasmus, you are entitled to purchase volumes in the edition at a discount of 40 per cent from the list price, and the cost of these volumes to you is therefore \$62 (\$57 plus \$5 for postage and packing).

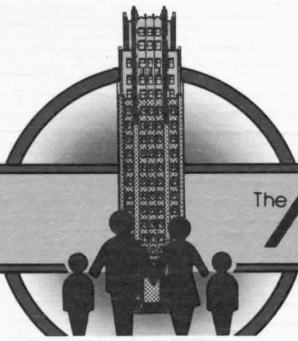



Dear Professor Domonkos:

The AHA provided me with a list of U.S. AHA member-participants in the recent Stuttgart Congress, and it is with that list that I am writing you to obtain your opinion on the matter of political resolutions at such congresses. I was one of those in attendance at the August 26, 1985, "Round Table" on "The Responsibilities of Historians and the Problems of Peace Maintenance" at which a resolution, prepared by Academician Tikhvinsky of the U.S.S.R., was modified by Professor Gordon Craig of the U.S.A. and Professor T. C. Barker of the U.K. into the following form and declared by the chair (Tikhvinsky) to be approved by those in attendance:

The Round Table, attended by 300 historians from all over the world at the 16th International Congress of Historical Sciences, deeply concerned by the dangers posed by the escalation of nuclear armaments and believing that the perspective provided by their discipline deserves serious consideration by national leaders charged with the formulation of policy, urgently appeals to all national governments to implement a universal freeze on the production of nuclear weapons and a cessation of nuclear testing as a necessary prelude to effective arms control and carefully phased disarmament.

This Round Table further believes that the historian's duty to warn mankind against the special dangers that confront it in the present age and the need to live in peace and cooperation fully justify this resolution.


I myself do not believe that taking positions on political issues is an appropriate activity for historians meeting as historians. I know many of you disagree with me. I am also sure that many of you will agree with the resolution co-sponsored by Tikhvinsky, Craig and Barker. However, whether you agree with the sentiments expressed in that resolution or not, some of you may feel that such resolutions are out of place in a historical congress and improperly presume to speak for other historians who may disagree with the sentiments

expressed. In order to provide an opportunity for members of the AHA to express their views on this subject at the December annual meeting, I have drawn up the following resolution, which I am considering submitting to the AHA prior to its November 1 deadline so that it can be printed in the December Perspectives.

RESOLVED: While recognizing that any individual serving as an officer of the International Committee of Historical Sciences (the international body with which the American Historical Association is affiliated) serves not as an instructed representative either of his own country or of the AHA, it is at the same time incompatible with such an individual's obligation to the discipline of history and to his colleagues in the AHA for him or her to sponsor, or join in sponsoring, resolutions asserting the special competence of "historians" or of the "historical profession" (other than himself or herself as an individual) to make recommendations concerning political issues, whether of a national or international character.



Dear Colleagues:

On October 23, 1985, Professor William Binning sent a letter to your Committee in which he expressed opposition to the inclusion of a history course in the proposed social studies requirement. The same letter was also circulated at the Arts and Sciences Chairmen's meeting on November 7. The arguments set forth by Dr. Binning are flawed and can not be left unanswered. Therefore, I would like to address myself to some of the issues he raised and present an opposing point of view.

It is surprising and also unfortunate when the inclusion of a history requirement has to be defended against the attacks of colleagues whose enthusiastic support one would have expected. To have an understanding of the historical process, to have students who are aware of the factors which have shaped our cultural, political and socio-economic development, should be welcomed by every member of the University faculty, but most certainly by those who teach in the social sciences and humanities.

Opposition to the inclusion of history as a University requirement seems to be even harder to understand when we examine the general trends in higher education today. In almost every instance where a serious examination of requirements was undertaken and a "core curriculum" was developed, courses in history are required. Dean Rosovsky's Harvard curriculum, for example, requires two semesters of history. As you know, the Harvard core curriculum has already been widely imitated in a variety of institutions, both private and public, large and small. Stanford University has a Western Civilization sequence requirement which every student must pass in order to graduate. Examples by the hundreds could be cited to support the fact that the inclusion of a history requirement is considered sound educational policy.

In the determination of what is included or excluded in a basic university curriculum, the primary consideration should always be the intellectual development of our students and not an effort to build "academic empires" or to "protect our turf." A requirement that students take at least one history course is an intellectually sound proposal.


It is interesting to note that Harvard, the University of Pennsylvania, Stanford and other first rate institutions which draw on the best high school graduates in the country, students who are usually widely traveled and highly literate, still require that their graduates take history courses. Many of our students whose academic preparation is less extensive, who come from a culturally deprived environment, would benefit greatly from exposure to the discipline of History. It would open up new horizons and decrease the provincialism of many of our pupils. A history requirement at Youngstown State University is far more vital to the educational development of our students than the same requirement at an "Ivy League" institution.

The most incomprehensible part of Professor Binning's argument is his insistence that history is the least typical of the social sciences and is not representative of its methodology or its content. First of all, we have to ask the question: On what authority Binning bases his assertion. Just because we say something does not necessarily make it true. While Dr. Binning's statement might have had some validity as a critique of the methodology of history as it was practiced a hundred years ago, it is certainly not true today. History has in fact been influenced by and has adopted much of the methodology of the other social sciences. For example, many historians regularly use the tools of anthropology and geography. Psycho-history is not a passing fad but has become a respected part of the profession. Quantification, population movements, sociological insights into history are all aspects of our discipline. Marxist as well as non-Marxist historians have made giant strides in the study of economic factors in the development of historical trends and events. Historians have learned much from their colleagues in the other social sciences and by incorporating some of this methodology into their own discipline, have strengthened the profession. History is in fact an excellent introduction to what social scientists do. The statement that it is the least typical discipline is obviously fallacious.





First of all, heartiest congratulations upon your superb lecture on Hutchins given at the XVith International Congress of Historical Sciences. Due to my multiple telephone calls (over \$20 paid from my own pocket) to arrange the Tübingen excursion on Friday morning, I could not attend your lectures. Blame the Commission!

The second congratulations are due upon your election as Treasurer into the Bureau of the Executive Council. Your elections taught me a lot. In order to secure this:

- a) I entertained the Polish man in Washington's Ritz Carlton Hotel for \$135.
- b) I invited him to dinner at the Schlossgarten Hotel for DM 320 = \$123.
- c) I discussed the whole election in our unofficial meeting in my hotel, entertaining them with four bottles of finest wine and salmon and fine ham with wines Verrenberger-Verrenberg from the Prinz Hohenlohe. Attending were Verger, Feenstra and the Polish man. No objection has ever been raised about your election.

This is just to inform you about the status of our Jaszi Memorial Conference, and to ask you to write us regarding your role in the program so that we can finalize it and prepare it for printing.

To assure a quality conference, we have sent out invitations to many of the foremost scholars on nationalism, Eastern Europe, and inter-ethnic relations. About forty-five have accepted some role in the conference. Enclosed I'm sending you a copy of the program on the basis of the commitments received to the present time.

Until recently, we had hopes of receiving significant foundation support for the conference. Unfortunately, this support did not materialize, and neither IREX nor the Council on Soviet and East European Research has provided us with the support that would have enabled us to cover the travel and living expenses of the participants. At the present time we are working on smaller grants and donations to cover some of our expenses. However, these will not provide funds for travel. Thus, we have to ask each of you to attend the Jaszi Conference on the assumption that your travel expenses will not be reimbursed for you.

We hope this will not cause undue hardship for you. For most of the American and Canadian scholars, we are hoping that their home institutions will cover the travel costs. For the six scholars from Eastern Europe we have pledges to cover their airfare. For a handful of real hardship cases, we may be able to raise the needed funds to cover part of their airfare. However, at the present time we cannot even guarantee this.

In view of the above, we would again like to ascertain your commitment to the conference. Please let us know if these changed circumstances will mean you cannot attend the conference. In the latter case, of course, your study or comments could still be included in the volume of collected studies that is being planned, even if your name and topic do not appear in the finalized Memorial Conference program (we will not read papers in abstentia).



Dear Colleague:

By this letter, I am requesting that you accept appointment to the University Research Council. The Board of Trustees' policies indicate that the Provost of the University shall appoint the members of the Research Council as well as its chairman. The bridging of the interests and responsibilities of the Academic Research Committee of the University Academic Senate with those of the University Research Council, where they exist, will be done by Dr. Sally Hotchkiss, the Graduate Dean, in serving as chairman of the University Research Council. I have every confidence in her ability to do so.

The charge to the University Research Council is that it be responsible for the stimulation and coordination of faculty research, sponsored research, and contract research activities on the campus. Part of this responsibility will be for the Council to receive faculty proposals submitted to it and to advance funding for those proposals on the basis of guidelines provided and subsequent relevant policies approved by the Board of Trustees, the President or other authorized body or person. In addition, the University Research Council shall concern itself with patent matters as may be required.

The current year's budget contains \$60,000 for research. The University will receive a partial match of outside non-state funds granted to it for research, from the Ohio Board of Regents under the Research Challenge Program. If the University Research Council members can formulate a means of providing additional encouragement of research, the administration will make attempts to provide these or more additional resources to do so.



Renaissance studies in the West, and in the U.S.A. in particular, concern themselves overwhelmingly with the development of the Renaissance in Western Europe. The ignorance of and inattention to the spread of humanism and the Renaissance among the peoples of Eastern Europe can only be understood in the context of the longstanding treatment of Eastern Europe as a cultural backwash of the West. The inability, or refusal, to see Europe as a whole in the study of intellectual and cultural movements which were diffused virtually through the entire continent not only limits an understanding of the full range of these movements and the various ways in which they were assimilated in different societies but, more perniciously, extends post-World War II political divisions into the cultural sphere. In the case of Renaissance studies, the widespread interest in the period and the sophistication of the scholarship on it make the neglect of Eastern Europe all the more regrettable and indefensible.

The ultimate goal of the proposed conference is to produce a volume of essays of a by and large general or synthetic nature on the most outstanding and characteristic expressions of Renaissance culture in Eastern Europe from the mid-15th through the late 16th centuries. The essays will be invited from authorities on the Renaissance in Eastern Europe. They may be written in whatever language the contributor prefers, but if not in English will be translated for publication so that the final volume can have its greatest resonance in this country. At the conference itself, which will not be open to the general public, abstracts of the essays will be presented and discussed particularly with an eye to achieving the best possible integration of the material for the planned volume. Since the participation primarily as commentators of a small number of Renaissance specialists who deal with Western Europe would be highly desirable, the principal contributors would be asked to prepare their presentations in English.

The conference, and the final volume, will not attempt to address any and all manifestations of Renaissance culture in Eastern Europe, but will concentrate only on those areas where there were significant achievements, that is Poland, Hungary, Bohemia, and Dalmatia. The topics for which contributions will be solicited are, tentatively, the following:

1. Humanism. Its dissemination and achievements in Eastern Europe. Particular emphasis will be placed on the role of Western Humanists in the diffusion of the movement in Eastern Europe, among them Filippo Buonaccorsi ("Callimachus"; in Poland), Konrad Celtis (in Cracow, Buda, and

Vienna), Pier Paolo Vergerio (in Buda), and Aeneas Sylvius Piccolomini (in Bohemia both through his contacts with Czechs when he served as imperial secretary in Vienna and on the basis of his keen interest in and writings on Bohemia when he reigned in the Vatican as Pope Pius II). The attempt will also be made to determine the nature of Dalmatian-Italian interaction in the development of a Dalmatian humanism and to isolate the factors supportive of a cultivation of the vernacular language in preference to Latin.

2. The constraints imposed on the flowering of a Renaissance culture in Bohemia by the Czech religious conflicts of the 15th and 16th centuries (Catholicism, Hussitism, the Unity of the Czech Brethren).

3. Cross fertilization among the East Europeans in the period of humanism. Of particular concern here will be the possible formative importance of Hungary and specifically the courts of János Vitéz at Esztergom and Matthias Corvinus at Buda for the development of Polish Renaissance culture. The first Polish Humanist, Grzegorz of Sanok, Archbishop of Lwów, whose court at Dunajów assumed the character of a Humanist salon, spent time in Hungary when the Italian presence there had increased considerably after Corvinus' marriage to Beatrix of Aragon, the daughter of the King of Naples. Other early standard-bearers of the Renaissance in Poland such as Filippo Buonaccorsi and Paweł of Krosno also visited Hungary, had connections with Hungarian culture and, together with Grzegorz of Sanok, appear to have served as a major point of contact between early Hungarian and Polish Renaissance cultures. Influence was not, however, a one-way street. Hungarian, as well as Czech, students unable to travel to Italy to study at the leading Renaissance centers enrolled at the universities of Cracow and Vienna which in the late 15th and 16th centuries were already undergoing the transition from medieval scholasticism to Renaissance humanism. A separate Hungarian residence, or bursa, existed in Cracow in the 15th century and the natio Hungarica was one of the four "nations" at the University of Vienna.

4. East European Renaissance literary achievement in the Latin language: Janus Pannonius (Hungary), Bohuslav Hasištejnský z Lobkovic (Bohemia), Klemens Janicki and Jan Kochanowski (Poland).

5. East European Renaissance literary achievement in the vernacular: the poetry of Jan Kochanowski (Poland) and Bálint Balassi (Hungary) and the drama of Marin Držić in Dalmatia. The controversy over the originality of the Dalmatian Petrarchists.

6. East European Renaissance historiography.

Although Professor Tibor Klaniczay, of the Hungarian Academy of Sciences and an authority on Hungarian Renaissance literature, will be unable to contribute to the volume, there is still the possibility of his participating in the conference. Invitations will also be sent to Professors Claude Backvis, of Belgium, and Ilya Golenishchev-Kutuzov, of the U.S.S.R., but age in both cases may make their active participation in the project as a whole out of the question.

If there is any other scholar or scholars you think should be a part of both the conference and the final volume, please let me know as soon as possible. Given the nature of the projected volume and the audience for which it is intended, the effort should be made first to identify scholars working on the Renaissance in Eastern Europe in the English-speaking world. The conference, and volume, should not be thought of primarily as a showcase for Western scholarship on the Renaissance in Eastern Europe, but both do present an opportunity to demonstrate current English-language work in the field. It is for that reason as well as for perspective that preference as to participation in the project as a whole is being given to non-East Europeans.

With the conference now scheduled for late August 1986, papers can be submitted up to about the middle of June. That should allow sufficient time for duplication, translation where necessary, and circulation among conference participants. Forgive me for bringing this up, but the papers must be fresh contributions. They can be extracted from larger works in progress, of course, but they should not be previously published articles or articles already under consideration for publication elsewhere. Your cooperation with respect to this matter in particular will be greatly

appreciated.

In the meantime, please do not hesitate to write me if you have any questions concerning both the conference and the volume of essays. Many thanks again for your interest and cooperation.

Dear Colleagues:

There is one major development to be reported at this time. In response to favorable outside reports on the progress of the conference, the Joint Committee on Eastern Europe of the American Council of Learned Societies, which is sponsoring the conference, has encouraged me to expand it to include participants who would be able to contribute essays on the visual arts and music in Eastern Europe during the Renaissance. The Committee would also like to see the participation of at least two specialists on the Renaissance in the West who would address themselves primarily to the issue of how best to integrate the Renaissance in Eastern Europe into the study and teaching of the Renaissance in general.

I am now working with the Committee on a list of additional scholars to be invited. The JCEE feels, however, that because of the expansion of the program, there is simply not enough time to have everything in place for the meeting to take place as originally planned in late August 1986, especially in view of the fact that the Committee would like all papers to be turned in some two months in advance in order to facilitate duplication, translation (where necessary), and circulation. The Committee has therefore asked me to postpone the conference for at least six months. Since it would seem best for us to meet when it would be easiest for all participants to attend and when there is a greater likelihood of favorable weather, we have decided to shift the conference date from late August 1986 to June 1987. I have already written to the Yugoslavs about our need to change the time of the meeting and have asked them to suggest the best dates for our use of the International Conference Center in Dubrovnik. As soon as the new date of the conference is fixed, I will pass the information on to you.

Needless to say, I very much regret this change of plans and any inconvenience that it may cause you. In view of the fact, however, that the ACLS, through the Joint Committee, is sponsoring the conference and allocating the funds that will make it possible, their wishes must be respected. Their position is, I believe, a reasonable one. If the scope of the conference can be broadened, as indeed it can be, and the possibility of its having a greater impact enhanced, then there is really no good reason not to postpone the meeting. The ACLS has, of course, expressed its willingness to cover the cost of the additional participants.

In light of this change of date, would you please let me know as soon as possible if you will still be able to participate? If so, I would ask you to consider preparing preliminary abstracts of your papers within the next three months so that they can be submitted to the JCEE at its spring

meeting. In my next communication, I will tell you what specific issues the Committee would like the papers to address, so that your abstracts can be written accordingly.

Further information:

1) We still have not received replies from Professors Tazbir and Pelc in Poland. We are now contacting them for a second time.


2) Professor Backvis and Golenishchev-Kutuzov, it turns out, are unfortunately both deceased. When I sent you my last letter, I was uncertain about the Soviet scholar, but I had absolutely no idea of the death of Prof. Bakvis, with whom I had exchanged correspondence in 1979 in connection with my own research.

3) Please correct the spelling of Prof. Joseph F. Zacek's name; it is Zacek, not Zaczek. (Apologies to Prof. Zacek!)

Commission internationale pour l'histoire des Universités
Procès verbal de la réunion des 29-30 août 1985

La Commission internationale pour l'histoire des Universités s'est réunie les 29 et 30 août 1985 dans le cadre du seizième Congrès international des Sciences historiques. Cette réunion a comporté deux parties.

1 - Un colloque scientifique qui s'est tenu le 29 août (séance plénière le matin - trois séances en sous-commissions l'après-midi) et le 30 août au matin à l'université de Stuttgart (RFA). Au cours de ces séances, des membres de la Commission et des historiens invités par celle-ci ont présenté 25 communications sur le thème: "Les carrières universitaires: cas individuels et profils collectifs". Le programme détaillé de ces séances avait été diffusé à l'avance par les soins de la Commission et reproduit dans le programme général du Congrès international des Sciences historiques. Au cours d'une des séances en sous-commission du jeudi après-midi, le professeur G. Arnaldi (Rome) est également intervenu pour présenter les activités du "Comitato per la Storia dell'Università di Roma".

2 - Une réunion administrative qui a eu lieu le vendredi 30 août après-midi à Tübingen à l'invitation de l'université de cette ville. Les membres de la Commission ont été accueillis dans la salle du Sénat de l'Université par le vice-président de celle-ci. Après avoir chaleureusement remercié celui-ci de son hospitalité, le professeur A.L. Gabriel (USA), président de la Commission, a ouvert la séance à 15 h 30.

Le président A.L. Gabriel a commencé par saluer les membres présents de la Commission (Mmes et MM. de Ridder, Monfrin, Verger, Fletcher, Feenstra, Maffei, Gieysztor) ainsi que les membres à titre intérimaire et les suppléants délégués par certains membres empêchés (Mme Falck pour la DDR, MM. Hammerstein (BDR), Kukushkin (URSS), Székely (Hongrie), Svatoš (Tchécoslovaquie)). Il présente ensuite les excuses des membres absents et donne en particulier communication d'une lettre du professeur S. Stelling-Michaud (Suisse), ancien président de la Commission qui regrette de ne pouvoir assister à cette réunion. On passe ensuite à l'ordre du jour.

1 - A la demande du président, M. J. Verger, secrétaire et trésorier de la Commission, présente le rapport financier. Depuis le Congrès international des Sciences historiques de Bucarest (1980), les recettes (cotisations versées par les membres de la Commission) et les dépenses (cotisation de la Commission au comité international des Sciences historiques) se sont établies comme suit:

Compte tenu du solde positif de 246,96 FF qui restait en caisse à la fin de l'exercice 1980, le déficit cumulé sur ces quatre années (1981 à 1984) se monte à 645,43 FF.

Ces chiffres appellent les commentaires suivants. Il apparaît que, malgré les résultats plus favorables enregistrés pendant l'exercice 1984, les recettes perçues par la Commission sont notoirement insuffisantes et ne couvrent même pas le montant annuel de notre cotisation au CISH (dont le paiement régulier est cependant indispensable si nous voulons garder notre statut d'organisme affilié au CISH). Il en résulte donc que la Commission ne dispose d'aucune ressource propre pour soutenir ses activités proprement scientifiques et que le solde même de notre cotisation au CISH ainsi que tous les frais de secrétariat restent à la charge personnelle du secrétaire et surtout du Président de la Commission. Il convient à cet égard de mentionner que l'université de Notre Dame (USA) a octroyé en 1984-85 au président A.L. Gabriel une subvention de 2500\$ qui lui a permis de couvrir tous les frais de préparation du colloque de Stuttgart (secrétariat, impression des programmes, etc.); la Commission remercie très vivement l'université de Notre Dame de cette généreuse contribution.

Il apparaît donc qu'un effort particulier doit être fait dans le domaine financier. M. Verger suggère, avant de penser à un relèvement du montant des cotisations (actuellement fixé à 50 FS), d'essayer de rétablir le contact avec les pays qui, faute d'un représentant titulaire actif dans la Commission, ont cessé depuis plusieurs années de payer leur cotisation; il souhaite aussi que nos collègues des pays socialistes puissent obtenir plus facilement les allocations en devises nécessaires. Il conclut que, pour mener à bien cet effort de redressement, il convient que la Commission, conformément à l'article 5 de ses statuts, élise dès à présent un trésorier à part entière dont la charge ne se confondrait plus avec celle de secrétaire. La première mission de ce nouveau trésorier sera de faire rentrer les cotisations 1985. Ce nouveau trésorier pourra par ailleurs disposer d'une somme de 859 FS actuellement détenue par Monsieur S. Stelling-Michaud; il s'agit du reliquat d'une subvention jadis reçue par celui-ci pour publier sous les auspices de la Commission le Corpus scolarium Bononiensium; comme M. S. Stelling-Michaud renonce à poursuivre lui-même cette entreprise (cf. infra), il est tout disposé à remettre cette somme à la Commission dès que la demande lui en sera présentée.

2 - A la demande du président, M. J. Verger, secrétaire de la Commission:

- informe celle-ci de l'existence d'une grande entreprise éditoriale lancée par la "Conférence des recteurs européens" (CRE), organisme dont le siège est à Genève (10, Conseil-Général, CH - 1211 Genève 4 - Suisse): il s'agit d'une histoire des universités européennes en 4 volumes; plusieurs membres de la Commission sont déjà membres du Comité de rédaction, auteurs de tel ou tel chapitre ou "correspondants nationaux" du projet; il est bon que tous soient informés de son existence et acceptent de fournir éventuellement aux auteurs de cet ouvrage les informations, bibliographiques ou autres, que ceux-ci pourraient être amenés à leur demander.

- fait part à la Commission de quelques réflexions que lui inspirent la situation actuelle de la Commission et ses perspectives d'avenir, notamment dans la perspective du renouvellement annoncé du bureau. Il constate d'abord que l'élargissement des intérêts scientifiques de la Commission "des origines à nos jours" implique, pour les XIXe et XXe siècles, une extension géographique mondiale et une ouverture aux multiples recherches de l'histoire contemporaine et de la sociologie; il conviendrait aussi de s'intéresser aux diverses formes non proprement universitaires d'enseignement supérieur. Ces élargissements souhaitables semblent difficilement compatibles avec le maintien des seules affiliations individuelles d'un ou deux "représentants" nationaux par pays; il faudrait sans doute mul-

tiplier, voire généraliser, les "sous-commissions nationales". Enfin, M. Verger se demande si, en sus de ses réunions périodiques et des colloques scientifiques auxquels elle participe, la Commission ne devrait pas lancer des projets collectifs de recherches (comme elle l'avait fait jadis en patronnant la composition d'une bibliographie internationale de l'histoire des universités) et se doter d'une publication spécifique qui ferait connaître ses activités et ses projets.

Une discussion s'engage entre les membres de la Commission à partir de ces observations. M. J. Fletcher insiste pour que des contacts soient pris avec les divers instituts et associations qui, dans plusieurs pays et en particulier dans les pays anglo-saxons, s'intéressent actuellement à l'histoire de l'enseignement et de l'éducation en général et, éventuellement, de l'enseignement supérieur. Certaines de ces institutions sont déjà très actives et, faute de contacts avec elles, la Commission risque de se trouver marginalisée par rapport à de nombreux secteurs actifs de la recherche historique. Le président A.L. Gabriel répond que la Commission n'a pas à rougir de son bilan, qu'elle jouit d'un grand prestige et que toutes les associations qui s'intéressent aujourd'hui à l'histoire des universités, ne sont pas d'un égal sérieux scientifique. En définitive, la Commission mandate M. J. Fletcher pour prendre contact, en Angleterre, avec les principales institutions spécialisées dans l'histoire de l'enseignement et faire rapport à la Commission, lors de sa prochaine réunion, sur les perspectives de collaboration ouvertes par ces contacts.

- fait part à la Commission d'une lettre reçue de M. S. Stelling-Michaud (Suisse) relative à la publication du Corpus scolarium Bononiensium; en raison de son état de santé et des difficultés rencontrées par cette entreprise qu'il avait lancée sous les auspices de la Commission, M. S. Stelling-Michaud renonce à s'en occuper; il remettra donc à la Commission le reliquat de la subvention qu'il avait reçue à cette fin (cf. supra) et transmettra aussi au secrétaire de la Commission toute la documentation réunie à ce jour, laissant à la Commission le soin, si elle le juge utile et possible, de poursuivre et d'achever l'entreprise sous la forme qui lui paraîtra la plus opportune.

4 - La Commission procède ensuite à l'élection des nouveaux membres destinés à remplacer les membres démissionnaires ou décédés.

Sont ainsi élus à l'unanimité: le professeur Notker Hammerstein (BDR) en remplacement du professeur H. Coing - le professeur Tore Frängsmyr (Suède) - le professeur Y.S. Kukushkin, vice-président du Comité national des Historiens soviétiques, pour l'URSS.

Pour le Japon, le professeur Hiroshi Mori est élu par 11 voix pour, 1 contre, 1 refus de vote.

Pour l'Autriche, 3 candidats étaient en présence: Mme le Professeur G. Klingenstein (Graz) - le Dr. Paul Uiblein (Vienne - Institut historique autrichien) - le professeur W. Höflechner (Graz). Au premier tour: Uiblein: 5 voix, Klingenstein: 6, Höflechner: 2; au 2e tour, Uiblein: 8 voix, Klingenstein: 5; le Dr. P. Uiblein est donc déclaré représentant de l'Autriche dans la Commission.

Le président A.L. Gabriel se réjouit de ce scrutin qui permet à nouveau à la Commission d'être au complet. Les nouveaux membres, déjà présents à Tübingen à titre intérimaire, à savoir MM. les professeurs N. Hammerstein et Y.S. Kukushkin, sont introduits dans la salle de séance et, après avoir reçu les félicitations du président, sont immédiatement invités à prendre part comme membres titulaires de la Commission à la suite des travaux de celle-ci.

5 - En raison de l'importance de l'ordre du jour, il est décidé

que le point 6 de celui-ci (activités des sous-commissions nationales) ne sera abordé que brièvement. Le président A.L. Gabriel porte à la connaissance de la Commission la composition de la sous-commission américaine. Le professeur Székely évoque les diverses activités de la sous-commission hongroise (colloques commémoratifs, fouilles archéologiques, bibliographie des travaux d'histoire universitaire des 40 dernières années, etc.). Le professeur Feenstra rappelle la création aux P.-B. du groupement Batavia Academica, qui publie un journal de même titre et prépare entre autres un colloque sur l'histoire de l'université de Franeker. Pour la Pologne, le professeur A. Gieysztor indique que, tous les deux ans, les historiens polonais intéressés par l'histoire des universités se réunissent à l'occasion de journées d'histoire universitaire organisées par l'université jagellonne de Cracovie. Pour la France, MM. Monfrin et Verger rappellent l'existence du "centre de recherche et de documentation sur l'histoire des universités" dirigé par Monsieur A. Tuilier, directeur de la Bibliothèque de la Sorbonne, qui est une institution implantée auprès de la Bibliothèque de la Sorbonne et est actuellement reconnue et subventionnée par le CNRS; ce centre pourrait être la base d'une véritable sous-commission française, si Monsieur Tuilier en est d'accord; MM. Monfrin et Verger prendront contact avec lui à ce sujet.

6 - Sur proposition de Monsieur le Professeur Feenstra, un article 9 ainsi rédigé est ajouté aux statuts de la Commission, par un vote unanime de celle-ci: "Pour la modification de ces statuts, la majorité des deux tiers des votants est requise".

7 - La Commission se réunira en 1990 dans le cadre du 17e Congrès international des Sciences historiques à Madrid (Espagne). Dès à présent, les membres de la Commission sont invités à réfléchir aux thèmes possibles de cette future réunion et à faire parvenir leurs suggestions, par lettre, au président de la Commission.

D'ici là, il serait très souhaitable que la Commission puisse tenir une ou deux réunions intermédiaires. Monsieur le professeur Maffei évoque la possibilité d'un colloque en Italie, peut-être en 1988 ou 1989. Surtout, Monsieur le Professeur Švatoš confirme que la Commission devrait être invitée à tenir sa prochaine réunion en Tchécoslovaquie, à une date qui pourrait être en mai 87. La Commission, unanime, le remercie très chaleureusement de cette invitation.

8 - Comme il avait été convenu lors de la précédente réunion de la Commission (Leipzig - octobre 1982), celle-ci procède au renouvellement de son bureau. Sont ainsi élus:

Président: Monsieur le Professeur R. FEENSTRA (P.-B.) (13 voix pour)

Vice-présidents: Messieurs les Professeurs Y.S. KUKUSHKIN (U.R.S.S.) (12 voix pour, 1 abstention)

D. MAFFEI (Italie) (12 voix pour, 1 abstention)

J. VERGER (France) (12 voix pour, 1 abstention)

Secrétaire général: Madame H. de RIDDER-SYMOENS (Belgique) (12 voix pour, 1 abstention)

Trésorier: Monsieur le Professeur L.S. DOMONKOS (U.S.A.) (11 voix pour, 2 abstentions).

Sur proposition de Monsieur le professeur Gieysztor, il est décidé par un accord unanime que ce nouveau bureau entrera pleinement en

fonction à la veille de la prochaine réunion de la Commission, c'est-à-dire de la réunion prévue à Prague en mai 1987 (cf. supra). Jusque là se placera une période transitoire pendant laquelle le bureau sortant gardera la charge de la gestion de la Commission et de sa représentation auprès du CISH, tout en associant étroitement le nouveau bureau à ses initiatives. De plus, le nouveau trésorier prendra immédiatement ses fonctions. Le secrétaire de la Commission actuellement en fonction veillera également à informer rapidement son successeur du fonctionnement du secrétariat et à lui transmettre toute la documentation nécessaire.

Il est d'autre part fixé que les président et vice-présidents sortants pourront, s'ils le désirent, continuer à être appelés comme conseillers auprès du nouveau bureau, sans droit de vote, conformément à l'usage en vigueur au sein même du CISH.

Enfin, il est décidé que Monsieur J. FLETCHER, sans être membre en titre du bureau, sera chargé plus particulièrement des activités d'édition et de publication de la Commission et pourra à ce titre participer à toutes les délibérations du bureau relatives à de telles questions.

9 - Pour clore la réunion, le président A.L. Gabriel se félicite du bon déroulement de cette séance. Il remercie tout particulièrement les membres du bureau sortant pour le travail accompli depuis 1974 et affirme sa confiance en l'avenir de la Commission.

La séance est levée à 19 h.



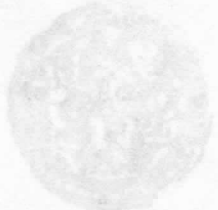

For years we have been good and close friends and I hope that the episode yesterday does not effect our relationship.

Please consider the following:

We were most enthusiastic about the recommendation of your committee that one course in History be a requirement in the Social Studies area. It was an academically sound decision, but obviously this "avant garde" campus is not ready for something that bold.

Once the Senate voted that History should not be singled out as a Social Studies area requirement, I felt betrayed. How can we consider people "educated" if they do not understand their own past. A core curriculum without a history requirement is, in my view, not a sound program. How would you feel if the Senate voted to eliminate literature from the Humanities section?? Probably the same way I felt about the loss of the history course.

Once the history requirement was eliminated from your proposal, the question was simply: are we in better shape with the present system which requires 16 hrs of Social Studies or the new recommendation, which reduced it to 12 hrs.

The answer is obvious.

Your anger and frustration at this point is understandable. You have worked so hard for so long and deserved a far better fate. Believe me, Barbara, when I say that I am sorry! I do hope that you will understand the reasons for voting the way I did. Under the circumstances it was the only logical course.

Dear Les,

Let me assure you that my friendship is not based on anything so flimsy as agreement on political issues or votes. School of Business already requires history and history has the resources to offer the multiple sections at various hours of the day that are crucial to enrollment in any course at the University.

What is more, you have to understand that there is nothing I can do now to get anything done. Because of the last committee's experience there was a reluctance to try again what it took me almost six months to overcome. I am obviously an optimist, but I felt that if the ball got rolling and the review of courses were attended to we could get rid of the Mickey Mouse courses. Most people's self interest dictates leaving it alone.
